Organized activities include bench rest, high power, and black powder rifle events; trap, skeet, and sporting clays events; IPSC, ICORE, Action Pistol handgun events; archery and Junior Shooting programs. We are fortunate to have several NRA Certified Instructors to teach classes in rifle, handgun, and shotgun safety. The range opens at 7:30AM on weekdays and 8:00AM on weekends, closing at sunset.

Club meetings are on the second Thursday of each month. During the December meeting elections of board members and club officers is held. Club meetings start at 7:00 PM and are open to all members.

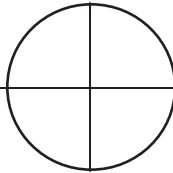

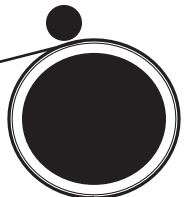
